

1 Q Okay. And what is the left labia?

2 A The labia is just -- the labia majora is really
3 the -- part of the genitalia of the female.

4 Q Okay.

5 A And it's very close to the area where the vaginal
6 entrance is.

7 Q And you say you found an inch and-a-half long
8 laceration on the left labia majora on this child?

9 A Yes, sir.

10 Q Okay. What else?

11 A She had multiple small abrasions.

12 Q Where were they at?

13 A I'm sorry?

14 Q Where were these small lacerations?

15 A She had multiple small abrasions of the introitus
16 and around the hymen, around the broken hymen. That would be
17 the introitus. Specifically mostly we refer it as -- to try
18 to specify the area where it is mostly, we refer it like as a
19 clock, you know, if you're looking at the vaginal entrance,
20 which is like a hole and it's round, you say at 2:00 o'clock.
21 You say at 2:00 o'clock that would give you a very good idea
22 of where, you know --

23 Q Okay.

24 A -- There was a significant tear there. And then
25 multiple small abrasions, you know, all around.

1 one and-a-half inches by the left labia majora.

2 Q Is that on the right side of the photograph as you
3 look at it?

4 A That's correct.

5 Q Okay. There is also broken hymen that looks well
6 healed. And dilatation of vaginal entrance. There is also
7 multiple abrasions around the vaginal entrance.

8 Q And what do those -- and if you need to hold that
9 photograph at an area where the jury can see what you're
10 talking about. Where are these lacerations you've described?

11 A Like we said, you know, the first one is on your
12 right, right -- it's kind of hard to explain so they can see
13 it.

14 Q Well, okay. Then just describe it and we'll hand
15 it to the jury in a little while and let them look.

16 A On the left side by the area of the labia majora,
17 right between the major and the minor -- you have to know
18 anatomy for this -- and a laceration that is one inch. And
19 it has kind of purplish coloration which is a result of the
20 toluidine blue applied to it. Around the hole -- the vaginal
21 entrance -- around that hole you can see also purplish blue
22 spots which indicate multiple abrasions.

23 Q What would the color of that area -- what would
24 you expect that color to be if there had not been any
25 lacerations there?

1 Number 3 on the grounds that they have not laid a proper
2 predicate for its introduction, sir.

3 THE COURT: Overruled. State's Exhibit

4 3 is admitted.

5 MR. CARROLL: Q Now, number three,
6 does it show any additional lacerations of the vaginal area
7 that you can't see in these first two photographs that have
8 been received?

9 A No, it doesn't.

10 Q What does it depict?

11 A It depicts the dilatation of the vaginal entrance
12 that compares the one as a sexually active adult and the
13 absence of a hymen.

14 Q Doctor, during that procedure when you had her in
15 the operating room, can you tell the jury how far down inside
16 that child's vaginal canal could you observe?

17 A It was about two inches inside the vaginal canal
18 that you could actually see without the walls collapsing in
19 midline, which is usually what happens.

20 Q Okay. And was your ability to see inside that
21 child a couple of inches, something you would expect to find
22 in an eight-year-old child?

23 A No, not at all.

24 Q Okay.
